O. Introduction

This is a call for proposals for EU action grants in the field of **Citizens' engagement** and participation under the Citizens, Equality, Rights and Value Programme (CERV). The regulatory framework for this EU Funding Programme is set out in:

- Regulation 2024/2509 ([EU Financial Regulation](#))¹
- the basic act (CERV Regulation [2021/692](#))².

The call is launched in accordance with the [2026-2027 Work Programme](#)³ and will be managed by the European Education and Culture Executive Agency (EACEA) ('Agency'). The call covers the following topic:

- **CERV-2026-CITIZENS-TOWN-TT — Town Twinning**

1. Background

The Citizens, Equality, Rights and Values programme (**hereafter 'the programme'**) **provides funding for citizens' engagement, equality for all**, and the implementation of rights and EU values. This programme brings together the former Rights, Equality and Citizenship programme and Europe for Citizens programme⁴.

The programme promotes exchanges between people of different countries, cultures, genders and socio-economic backgrounds, reinforces mutual understanding and tolerance and gives them the opportunity to broaden their perspective and develop a sense of European belonging and identity through "Town-Twinning and Networks of towns" projects.

In particular, Town Twinning projects aim at promoting exchanges between citizens of different countries to reinforce mutual understanding and tolerance and to give them the opportunity to broaden their perspective and develop a sense of European belonging and identity. While maintaining a bottom-up approach, the Town Twinning call for proposals provides an opportunity to focus on EU priorities covered by other strands of the programme. This means, for example, improving local knowledge on the EU Charter of Fundamental Rights, **including children's rights**, the rights deriving from EU citizenship, or building knowledge and sharing best practices on the benefits of diversity and gender equality, and encouraging citizens engagement, including children, in democratic life. Finally, the [European Capitals of Inclusion and Diversity award](#) will recognise the role that cities and local authorities play in fostering diversity and inclusion, and the [Access City Award](#) will reward EU cities that are making outstanding efforts to become accessible for persons with disabilities..

This Call for proposals aims to support the following policy initiatives: [European democracy action plan](#), [the Anti-racism Strategy \(2026-2030\)](#), [the EU Roma strategic framework for equality, inclusion and participation \(2020-2030\)](#), promoting diversity and inclusion (the EU Platform of [Diversity Charters](#)), [Strategy to strengthen the application of the Charter of Fundamental Rights in the EU](#), [EU Citizenship Report 2020](#), [the Roadmap for Women's Rights](#) and [the Gender Equality Strategy 2026-2030](#), [the LGBTIQ+ equality strategy \(2026-2030\)](#), [the Strategy for the Rights of Persons with Disabilities \(2021-2030\)](#), [the EU Strategy on the rights of the child](#), [the EU citizenship package](#), Recommendation on inclusive and resilient elections, as part of [the 'Defence of Democracy package'](#), and [the European Democracy Shield \(2025\)](#), which recognises that engaged and empowered citizens and an active civil society are the backbone of democracy. Ensuring a positive, inclusive and secure environment, which empowers political candidates to enter and stay in politics, and those elected or in public offices to safely exercise their responsibilities is essential for the quality of our democratic processes. [Strengthening the resilience of electoral processes](#), including at local level, is also of crucial importance. Promoting citizenship education, including media, digital literacy and critical thinking strengthen awareness of risks and threats and empowers citizens of all ages across all citizens of all ages across all communities to navigate the information environment, access reliable information, exercise their democratic rights **and engage in democratic processes. Promoting citizens' engagement in the democratic**

life, through support to participatory and deliberative tools, is also needed to reinforce ownership, empowerment and public trust. To address growing challenges such as social fragmentation, digital isolation, and declining trust in public institutions, the Commission will foster community-building approaches. Together with local authorities and networks across the EU – including the EU Network of Local Councillors – the Commission will encourage and support grassroots initiatives that bring together people of different ages and backgrounds and strengthen local connections and inclusive public spaces, including through sports, music, storytelling and collaboration, with the aim of promoting democratic dialogue, intergenerational participation and community-based engagement in democratic life.

2. Objectives — Themes and priorities — Activities that can be funded — Expected impact

Objectives

This call aims to promote exchanges between citizens of different countries, in particular through town-twinning, to give them practical experience of the wealth and diversity of the common heritage of the Union and to make them aware that these constitute the foundation for a common future.

More specifically:

- **promote exchanges between citizens of different countries;**
- give citizens practical experience of the wealth and diversity of the common heritage of the Union and to make them aware that these constitute the foundation for a common future;
- empower citizens of all ages across all communities to navigate the information environment, access reliable information, exercise their democratic rights and engage in democratic processes;
- strengthen the resilience of electoral processes, including at local level, which are essential to enable citizens to participate meaningfully in the political life, choose their representatives, and fully exercise their rights and freedoms;
- **promote citizens' engagement in the democratic life, through support to participatory and deliberative tools to reinforce ownership, empowerment and public trust;**
- guarantee peaceful relations between Europeans and to ensure their active participation at the local level;
- **promote a positive, inclusive and secure environment, which empowers all political candidates to enter and stay in politics, and those elected or in public offices to safely exercise their responsibilities, including at local level;**
- reinforce mutual understanding and friendship between European citizens;
- **encourage cooperation between municipalities and the exchange of best practices, including on participatory governance, citizen engagement and on fostering inclusive and discrimination-free environments for all;**
- **support good local governance and**
- **reinforce the role of local and regional authorities in the European integration process and in fostering societal resilience and democratic participation at grassroots level.**

It is expected that Town-Twinning projects will reflect on a new narrative for Europe, be citizen-oriented, equality promoting, violence-free, forward-looking, constructive and more engaging for children and the younger generation in particular. Projects may **be based on the outcome of citizens' consultations and may lead to debates about concrete ways to create a more democratic Union, to enable citizens to re-engage with the EU and to develop a stronger sense of ownership of the European project.**

Themes and priorities (scope)

The CERV programme helps to promote intercultural dialogue by bringing people of different nationalities and different languages together and giving them the opportunity to participate in common activities. In this context, Town-Twinning projects will raise awareness of the richness of Europe's cultural and linguistic environment and promote mutual understanding and respect, contributing to the development of a respectful, dynamic and multifaceted European identity and the respect of common values, equality, democracy and fundamental rights.

In view of this overall objective, the projects may address the following priorities (the list is not exhaustive):

- Fostering active citizenship and democratic participation at local level, including through actions under the European Democracy Shield, such as **strengthening the network of local councillors, promoting citizens' and youth participation** as well as initiatives that promote democratic engagement through participatory and deliberative tools; Promoting inclusion, equality and respect for diversity, including by addressing racism and supporting the empowerment and visibility of people and communities affected by racial or ethnic discrimination;
- Raising awareness of EU values, rights and democratic standards;
- Strengthening social resilience and address local challenges, including by promoting community engagement, improving media and digital literacy, and reinforcing the resilience of electoral processes, including at local level;
- Supporting community-based action to prevent and raise awareness of violence including domestic violence and violence against children, and promoting inclusive approaches to local well-being;
- Encouraging cultural participation and heritage;
- Fostering accessibility for persons with disabilities and participation initiatives for full inclusion in society and economy on an equal basis with others.

Activities that can be funded (scope)

Activities related to Town-Twinning may include, among others:

- workshops,
- seminars,
- conferences,
- training activities,
- expert meetings,
- awareness-raising activities,
- cultural events, festivals, exhibitions,
- gathering and consultation of (age and sex-disaggregated) data,
- development, exchanges and dissemination of good practices among public authorities and civil society organisations, development of communication tools and the use of social media.

Examples of the above list could include the two following activities:

- Promotion of new and meaningful methods, including participatory and deliberative tools to get involved in democratic debates and in public policymaking, enriching deliberations and reinforcing representative democracy based on elections.
- Use of innovative digital tools and participatory approaches to support **citizens' engagement in democratic life, including local digital platforms and**

civic tech solutions that complement in-person exchanges and foster inclusive participation.

The gender equality perspective should be taken into account when designing and implementing the project activities, to ensure that they are accessible to women and men on equal terms, and both women and men are able to participate in the activities.

The design and implementation of the projects are expected to promote gender equality and non-discrimination mainstreaming within the scope of the activities. For example, applicants should conduct and include in their proposal a [gender analysis](#) of topics addressed by project activities. This can help to contextualise experiences and needs of Europeans of different gender. It can also map the different impact that the project and its activities could potentially have on women and men as well as on girls and boys in all their diversity. To this end, applicants are encouraged to consult the key questions listed on the "EIGE [website](#)" **when conducting their gender analysis. This analysis could help avoid any unintended negative effects of the intervention on either gender (do no-harm approach)** ⁵.

Applicants are expected to design and implement their communication and dissemination activities in a gender-sensitive way. This includes, in particular, usage of gender-sensitive language. The same applies to the design and implementation of monitoring and evaluation activities. Proposals that integrate a gender perspective across all their activities will be considered of higher quality.

If the project is of a very small scale and limited to one type of activity such as for example cultural events, the reflection on the gender perspective may be adjusted to the scope of your project.

Projects involving children should ensure that children's rights, including their rights to be heard and to participate⁶ is respected. These projects activities shall ensure that actions are adequate to the age and gender specific needs of children. As a good practice, organisations that already work with children could consult them on the project proposal and include reflections/references to this process in the applications. Voices of children can also be brought in, based on direct participation and consultations, **available reports and documents recording children's opinions and needs**.

Accessibility for persons with disabilities must be ensured in the design and implementation of the project. All deliverables, including events, travel, documents, and communications materials, will have to comply with the online accessibility requirements, and include various means to accommodate the needs of persons with different kinds of disabilities, when needed. Attention should also be paid to the inclusion and meaningful participation of people subjected to racism and racial discrimination, ensuring that their experiences and perspectives are reflected in project design and implementation.

Expected impact

- Strengthened mutual understanding and friendship among citizens at local level;
- Better opportunities for citizens to experience and appreciate the added value of the EU through a grassroots, community-based approach;

- An increased sense of belonging to the EU; including increased democratic dialogue, intergenerational participation and community-based engagement in democratic life, increased use of participatory and deliberative tools to get involved in democratic debates and in public policymaking, enriching deliberations and reinforcing representative democracy based on elections, increased empowerment of citizens to navigate the information environment and access reliable information reducing social fragmentation, digital isolation, and declining trust in public institutions;
- Long-lasting bond between municipalities and between citizens, fostering community-building approaches, strengthening local democracy, inclusion and **participatory approaches, including citizens' engagement in democratic life;**
- Increased cross-border cooperation on similar practical issues of democratic participation between municipalities and between citizens, going beyond cultural exchanges;
- Increased effectiveness of prevention policies at local level aimed at preventing against domestic violence and violence against children⁷;
- Increased inclusion of marginalised communities, disadvantaged groups and groups at risk of discrimination;
- Improved accessibility for persons with disabilities and better inclusion in the community;
- Increased citizen participation in inclusive and meaningful cultural activities **and organisations and increased citizens' contact with Europe's rich cultural heritage**, particularly of people belonging to disadvantaged and marginalised communities or to groups at risk of discrimination and children.

3. Available budget

The estimated available call budget is EUR 6 000 000.

5. Admissibility and documents

Proposals must be submitted before the call deadline (*see timetable section 4*).

Proposals must be submitted electronically via the Funding & Tenders Portal Electronic Submission System (accessible via the Topic page in the [Search Funding & Tenders](#) in the [Calls for proposals](#) section Paper submissions are NOT possible.

Proposals (including annexes and supporting documents) must be submitted using the forms provided *inside* the Submission System (⚠ NOT the documents available on the Topic page — they are only for information).

Proposals must be complete and contain all the requested information and all required annexes and supporting documents:

- Application Form Part A — contains administrative information about the participants (future coordinator, beneficiaries and affiliated entities) and the summarised budget for the project (*to be filled in directly online*);
- Application Form Part B — contains the technical description of the project (*to be downloaded from the Portal Submission System, completed and then assembled and re-uploaded*);
- Part C (KPI tool) — contains additional project data regarding **the project's** contribution to EU programme key performance indicators (*to be filled in directly online, all sections to be completed*);
- mandatory annexes and supporting documents (*templates available to be downloaded from the Portal Submission System, completed, assembled and re-uploaded*):
 - list of previous projects (key projects for the last 4 years) (*template available in Part B*). Not applicable for newly established organisations;
 - a letter of support signed by the Municipality (applicable to applicants **and partners under the category** "Non-profit organisation representing local authorities"). The document must be provided at the latest during GAP stage;
 - Private entities directly involving children in the activities of the project must provide a Child Protection Policy (CPP) covering the four areas described in [Keeping Children Safe Child Safeguarding Standards](#). The CPP must be available online and transparent to everyone who comes in contact with the organisation.
It must include clear information about the recruitment of staff (including trainees and volunteers) and include background checks (vetting). It must also include clear procedures and rules to staff, including reporting rules, and continuous training.
 - Public entities (e.g. local authorities, ministries, etc.) can satisfy this obligation by submitting [a declaration on honour](#) from their legal


representatives stating that the child protection measures of the public entity are in line with the principles and standards described in the [Keeping Children Safe Child Safeguarding Standards](#).

At proposal submission, you will have to confirm that you have the mandate to act for all applicants. Moreover, you will have to confirm that the information in the application is correct and complete and that the participants comply with the conditions for receiving EU funding (especially eligibility, financial and operational capacity, exclusion, etc). Before signing the grant, each beneficiary and affiliated entity will have to confirm this again by signing a declaration of honour (DoH). Proposals without full support will be rejected.

Your application must be readable, accessible, and printable (please check carefully the layout of the documents uploaded)

Proposals are limited to maximum 40 pages (Part B). Evaluators will not consider any additional pages.

You may be asked at a later stage for further documents (*for legal entity validation, financial capacity check, bank account validation, etc*).

6. Eligibility

Eligible participants (eligible countries)

In order to be eligible, the applicants (beneficiaries) must:

- be legal entities (public or private bodies)
- be established in one of the eligible countries, i.e.:
 - EU Member States (including overseas countries and territories (OCTs))
 - non-EU countries:
 - countries associated to the CERV Programme or countries which are in ongoing negotiations for an association agreement and where the agreement enters into force before grant signature ([list of participating countries](#)).

  Please check the list regularly, to get the latest status on countries in the process of association.

- other eligibility conditions:

- Lead applicant and its associated partner(s) must be a public body or a non-profit organisation with legal personality formally established in one of the eligible countries.
- They must be towns/municipalities and/or other levels of local authorities or their twinning committees or other non-profit organisations representing local authorities.
- The project must be transnational and must involve municipalities from at least two eligible countries of which at least one is an EU Member State.
- Activities must take place in any of the eligible countries participating in the project.

- Events must involve a minimum of 50 direct participants, of which a minimum of 25 participants are "invited international **participants**"⁸

Beneficiaries and affiliated entities must register in the [Participant Register](#) — before submitting the proposal — and will have to be validated by the Central Validation Service (REA Validation). For the validation, they will be requested to upload documents showing legal status and origin.

Other entities may participate in other consortium roles, such as associated partners, subcontractors, third parties giving in-kind contributions, etc (*see section 13*).

Specific cases and definitions

Natural persons — Natural persons are NOT eligible (with the exception of self-employed persons, i.e. sole traders, where the company does not have legal personality separate from that of the natural person).

International organisations — International organisations are eligible. The rules on eligible countries do not apply to them.

Entities without legal personality — Entities which do not have legal personality under their national law may exceptionally participate, provided that their representatives have the capacity to undertake legal obligations on their behalf and offer guarantees for the protection of the EU financial interests equivalent to that offered by legal persons⁹.

EU bodies — EU bodies (with the exception of the European Commission Joint Research Centre) can NOT be part of the consortium.

Programme Contact Points — Are eligible as coordinator or beneficiary in this call, if they have procedures to segregate the project management and the information provision functions and if they are able to demonstrate cost separation (i.e. that their project grants do not cover any costs which are covered by their other grant). This requires the following:

- use of analytical accounting which allows for a cost accounting management with cost allocation keys and cost accounting codes AND application of these keys and codes to identify and separate the costs (i.e. to allocate them to either one of the two grants)
- recording of all real costs incurred for the activities that are covered by the two grants (including the indirect costs)
- allocation of the costs in a way that leads to a fair, objective and realistic result.

Associations and interest groupings — Entities composed of members may participate as **'sole beneficiaries'** or **'beneficiaries without legal personality'**¹⁰. ⚠ Please note that if the action will be implemented by the members, they should also participate (either as beneficiaries or as affiliated entities, otherwise their costs will NOT be eligible).

Countries currently negotiating association agreements — Beneficiaries from countries with ongoing negotiations for participation in the programme (*see list of participating countries above*) may participate in the call and can sign grants if the negotiations are

concluded before grant signature and if the association covers the call (i.e. is retroactive and covers both the part of the programme and the year when the call was launched).

EU restrictive measures — Special rules apply for entities subject to [EU restrictive measures](#) under Article 29 of the Treaty on the European Union (TEU) and Article 215 of the Treaty on the Functioning of the EU (TFEU)¹¹. Such entities are not eligible to participate in any capacity, including as beneficiaries, affiliated entities, associated partners, subcontractors or recipients of financial support to third parties (if any).

EU conditionality measures — Special rules apply for entities subject to measures adopted on the basis of EU Regulation 2020/2092¹². Such entities are not eligible to participate in any funded role (beneficiaries, affiliated entities, subcontractors, recipients of financial support to third parties, etc.). Currently such measures are in place for Hungarian public interest trusts established under the Hungarian Act IX of 2021 or any entity they maintain (see [Council Implementing Decision \(EU\) 2022/2506](#), as of 16 December 2022).

Consortium composition

Only applications by single applicants are allowed (single beneficiaries).

Proposals must involve municipalities from at least 2 eligible countries of which at least one is an EU Member State.

Applicants that are non-profit organisations representing municipalities will be required to clearly explain in the proposal the role and involvement of municipalities in the project thus proving their participation and commitment.

Eligible activities

Applications will only be considered eligible if their content corresponds wholly (or at least in part) to the topic description for which they are submitted.

Eligible activities are the ones set out in section 2 above and submitted by towns/municipalities or their twinning committees or networks, other levels of local/regional authorities; federations/associations of local authorities; non-profit organisations representing local authorities.

Town-Twinning events must involve a minimum of 50 direct participants, of which a minimum of 25 participants are "invited international participants". "Invited international participants" are delegations from associated partners travelling from a country to another country hosting a Town-Twinning event.

Projects will need to demonstrate a particular added value in the description of the activities (e.g. innovation, best practices).

Applications that are repeated from one year to the other submitted by the same applicant should demonstrate in the application the added value of the new action/continuation of the action.

The following activities are not considered as eligible for funding under this call

- online events. Online activities, such as webinars, can be part of the project but will not be considered for funding for the calculation of the number participants.

Projects should take into account the results of projects supported by other EU funding programmes. The complementarities must be described in the project proposals (Part B of the Application Form).

Projects must comply with EU policy interests and priorities (*such as environment, social, security, industrial and trade policy, etc*). Projects must also respect EU values and European Commission policy regarding reputational matters (*e.g. activities involving capacity building, policy support, awareness raising, communication, dissemination, etc*)¹³.

Financial support to third parties is not allowed.

Geographic location (target countries)

Proposals must relate to activities taking place in the eligible countries (*see above*).

Duration

Projects should normally range between *6 and 12* months.

Extensions are possible, if duly justified and through an amendment.

Project budget (maximum grant amount)

Project budgets are expected to range between EUR 8.455 and EUR 50.745 per project.

The grant awarded may be lower than the amount requested.

Ethics and EU values

Projects must comply with:

- highest ethical standards
- EU values based on Article 2 of the Treaty on the European Union and Article 21 of the EU Charter of Fundamental Rights and
- other applicable EU, international and national laws (including the General Data Protection Regulation [2016/679](#)).

Projects must seek to promote gender equality and non-discrimination mainstreaming in accordance with the [Gender Mainstreaming Toolkit](#). Project activities should contribute to the equal empowerment of women and men in all their diversity, ensuring that they achieve their full potential and enjoy the same rights. They should also seek to reduce levels of discrimination suffered by particular groups (as well as those at risk of multiple discrimination) and to improve equality outcomes for individuals. Proposals should integrate gender and non-discrimination considerations in proposals and target a gender-balanced representation in project teams and activities. It is also important that individual data collected by the beneficiaries are broken down by sex ([sex-disaggregated data](#)), disability or age whenever possible.

Applicants must show in their application that they respect ethical principles and EU

values based on Article 2 of the Treaty on the European Union and Article of the 21 EU Charter of Fundamental Rights.

Private entities with activities involving children must provide their child protection policy (CPP) covering the four areas described in the [Keeping Children Safe Child Safeguarding Standards](#). This policy must be available online and transparent to everyone who contacts the organisation. It must include clear information about the recruitment of staff (including trainees and volunteers) and include background checks (vetting). It must also include clear procedures and rules to staff, including reporting rules, and continuous training.

Public entities involving children must provide [a declaration of honour](#) - (template available to be downloaded from the Portal Submission System completed and attached to the Application) or their child protection policy (CPP), if any.

7. Financial and operational capacity and exclusion

Financial capacity

Applicants must have stable and sufficient resources to successfully implement the projects and contribute their share. Organisations participating in several projects must have sufficient capacity to implement all these projects.

The financial capacity check will be carried out on the basis of the documents you will be requested to upload in the [Participant Register](#) during grant preparation (*e.g. profit and loss account and balance sheet, business plan, audit report produced by an approved external auditor, certifying the accounts for the last closed financial year, etc*). The analysis will be based on neutral financial indicators, but will also take into account other aspects, such as dependency on EU funding and deficit and revenue in previous years.

The check will normally be done for all coordinators, except:

- public bodies (entities established as public body under national law, including local, regional or national authorities) or international organisations.
- if the project requested grant amount is not more than EUR 60 000.

If needed, it may also be done for affiliated entities.

If we consider that your financial capacity is not satisfactory, we may require:

- further information.
- an enhanced financial responsibility regime, i.e., joint and several responsibilities for all beneficiaries or joint and several liability of affiliated entities (*see below, section 10*).

- prefinancing paid in instalments.
- (one or more) prefinancing guarantees (*see below, section 10*).

or

- propose no prefinancing.
- request that you are replaced or, if needed, reject the entire proposal.

 For more information, see [Rules for Legal Entity Validation, LEAR Appointment and Financial Capacity Assessment](#).

Operational capacity

Applicants must have the know-how, qualifications, and resources to successfully implement the projects and contribute their share (including sufficient experience in projects of comparable size and nature).

This capacity will be assessed together with the 'Quality' award criterion, on the basis of the competence and experience of the applicants and their project teams, including operational resources (human, technical and other) or, exceptionally, the measures proposed to obtain it by the time the task implementation starts.

If the evaluation of the award criterion is positive, the applicants are considered to have sufficient operational capacity.

Applicants will have to show their capacity via the following information:

- general profiles (qualifications and experiences) of the staff responsible for managing and implementing the project
- description of the consortium participants
- list of previous projects (key projects for the last 4 years; *template available in Part B*).

Additional supporting documents may be requested, if needed to confirm the operational capacity of any applicant.

Public bodies, Member State organisations and international organisations are exempted from the operational capacity check.

Exclusion

Applicants which are subject to an EU exclusion decision or in one of the following exclusion situations that bar them from receiving EU funding can NOT participate¹⁴:

- bankruptcy, winding up, affairs administered by the courts, arrangement with creditors, suspended business activities or other similar procedures (including procedures for persons with unlimited liability for **the applicant's** debts)
- in breach of social security or tax obligations (including if done by persons with **unlimited liability for the applicant's** debts)
- guilty of grave professional misconduct¹⁵ (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the grant)
- committed fraud, corruption, links to a criminal organisation, money laundering, terrorism-related crimes (including terrorism financing), child labour or human trafficking (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the grant)
- shown significant deficiencies in complying with main obligations under an EU procurement contract, grant agreement, prize, expert contract, or similar

Applicants will also be rejected if it turns out that¹⁷:

- during the award procedure they misrepresented information required as a condition for participating or failed to supply that information
- they were previously involved in the preparation of the call and this entails a distortion of competition that cannot be remedied otherwise (conflict of interest).

8. Evaluation and award procedure

The proposals will have to follow the standard submission and evaluation procedure (one-stage submission + one-step evaluation)

An evaluation committee (assisted by independent outside experts) will assess all applications. Proposals will first be checked for formal requirements (admissibility, and eligibility, *see sections 5 and 6*). Proposals found admissible and eligible will be evaluated against the operational capacity and award criteria (*see sections 7 and 9*) and then ranked according to their scores.

For proposals with the same score a priority order will be determined according to the following approach:

Successively for every group of *ex aequo* proposals, starting with the highest scored group, and continuing in descending order:

- 1) The *ex aequo* proposals within the same topic will be prioritised according to the scores they have been awarded for the award criterion '**Relevance**'. When these scores are equal, priority will be based on their scores for the criterion '**Quality**'. When these scores are equal, priority will be based on their scores for the criterion '**Impact**'.

All proposals will be informed about the evaluation result (evaluation result letter). Successful proposals will be invited for grant preparation; the other ones will be put on the reserve list or rejected.



No commitment for funding — Invitation to grant preparation does NOT constitute a formal commitment for funding. We will still need to make various legal checks before grant award: *legal entity validation, financial capacity, exclusion check, etc.*

Grant preparation will involve a dialogue in order to fine-tune technical or financial aspects of the project and may require extra information from your side. It may also include adjustments to the proposal to address recommendations of the evaluation committee or other concerns. Full compliance will be a pre-condition for signing the grant.

If you believe that the evaluation procedure was flawed, you can submit a complaint (following the deadlines and procedures set out in the evaluation result letter). Please note that notifications which have not been opened within 10 days after sending will be considered to have been accessed and that deadlines will be counted from opening/access (*see also [Funding & Tenders Portal Terms and Conditions](#)*). Please also be aware that for complaints submitted electronically, there may be character limitations.

9. Award criteria

The award criteria for this call are as follows:

1. **Relevance:** extent to which the proposal matches the priorities and objectives of the call; clearly defined needs and robust needs assessment; clearly defined target group, with gender perspective being appropriately taken into account; contribution to the EU strategic and legislative context; European/trans-national dimension; impact/interest for a number of countries (EU or eligible non-EU countries); possibility to use the results in other countries (potential for transfer of good practices); potential to develop mutual trust/cross-border cooperation, building synergies and avoiding duplication with projects funded by other Union programmes or previous projects (40 points)
2. **Quality:** clarity and consistency of project; logical links between the identified problems, needs and solutions proposed (logical frame concept); methodology for implementing the project with gender perspective being appropriately taken into account (organisation of work, timetable, allocation of resources and distribution of tasks between partners, risks & risk management, monitoring and evaluation); ethical issues and measures/policies to guarantee compliance with EU values are addressed ; feasibility of the project within the proposed time frame (40 points)
3. **Impact:** ambition and expected long-term impact of results on target groups/general public; appropriate dissemination strategy for ensuring sustainability and long-term impact; potential for a positive multiplier effect; sustainability of results after EU funding ends (20 points)

Proposals that pass the individual threshold **for the criterion 'Relevance'** AND the overall threshold will be considered for funding — within the limits of the available budget (i.e. up to the budget ceiling). Other proposals will be rejected.

10. Legal and financial set-up of the Grant Agreements

If you pass evaluation, your project will be invited for grant preparation, where you will be asked to prepare the Grant Agreement together with the EU Project Officer.

This Grant Agreement will set the framework for your grant and its terms and conditions, in particular concerning deliverables, reporting and payments.

The Model Grant Agreement that will be used (and all other relevant templates and guidance documents) can be found on [Portal Reference Documents](#).

Starting date and project duration

The project starting date and duration will be fixed in the Grant Agreement (*Data Sheet, point 1*). The starting date should be after grant signature (normally within 6 months).

A retroactive starting date can be granted exceptionally for duly justified reasons but never earlier than the proposal submission date.

Project duration: see section 6 above.

Milestones and deliverables

Activities must be grouped into one work package which are major sub-divisions of the project (e.g. Project Management and Coordination, Communication and Dissemination, etc.). For Town Twinning, the project activities must be organised as one single work package (WP).

For this work package, an objective and lists of tasks/activities milestones and deliverables must be defined. The deliverables and milestones must be quantifiable and measurable. Their structure should be logical and guided by identifiable outputs with clear indicators.

The milestones (not applicable to Town Twinning Call) and deliverables for each project will be managed through the Portal Grant Management System and will be reflected in Annex 1 of the Grant Agreement.

This one work package should correspond to one or several events in the application form. Use a single work package for the total duration of the action and a single deliverable per event.

In total you will have one work package and two or more deliverables according to the number of events. The deliverables must be submitted after the end of each event.

1 work package = 1 or more event(s) = one or several activities

The deliverables of the work package must include the Event Description Sheet per event (mandatory document). Event Description Sheets must be published on the webpage of the municipality/coordinator for the selected projects and could also include, agendas or minutes of meetings, evaluation and/or quality control reports, a set of indicators for the assessment of activities and their impact, conception/planning reports, brochures, recommendations, and other strategic documents which contain the conclusions of the activities. For each event a signed and dated attendance list should be available, as well as proof of travel and subsistence of all international participants and kept by the project coordinator for any checks and audits by the EU services as stated in article 25 of the grant agreement.

An event is one or a series of activities, not necessarily performed on the same day, aiming at gathering people involving direct and verifiable participation of the target group(s) to discuss a thematic defined in advance. An event aims at reaching a determined output as defined in the work package of reference. To be eligible for funding, the total number of direct participants involved in the event must comply with the minimum requirements of participants/countries set in the lump sum decision.

Double funding is not allowed. Therefore, direct participants can be counted only once for the whole event under the same work package, even if they participate in several activities/ projects.

Form of grant, funding rate and maximum grant amount

The grant parameters (*maximum grant amount, funding rate, total eligible costs, etc*) will be fixed in the Grant Agreement (*Data Sheet, point 3 and art 5*).

Project budget (maximum grant amount): see section 6 above.

The grant will be a lump sum grant. This means that it will reimburse a fixed amount, based on a lump sum or financing not linked to costs. The amount will be fixed by the granting authority on the basis of the variable amounts it has prefixed, and the estimates indicated by the beneficiaries in their project budget. Project budget should **be established by filling out the lump sum budget in the Application Part A ("Work packages" and "Beneficiary Calculation Sheet"), to be filled directly online.**

Budget categories and cost eligibility rules

The budget categories and cost eligibility rules are fixed in the Grant Agreement (*Data Sheet, point 3, art 6 and Annex 2*).

Budget categories for this call:

- Lump sum contributions¹⁸

Specific cost eligibility rules for this call:

- the lump sum amount must be calculated in accordance with the methodology set out in the lump sum decision and by filling out the Administrative forms (Part A) ('Work packages' section).
- the lump sum calculation should respect the following conditions: number of invited international participants (number of participants from associated partners travelling from a country to another country hosting a Town-Twinning event).

EU officials shall not be counted for the purposes of the calculation of the lump sum thresholds, in accordance with the Decision authorising the use of lump sums for actions under the Citizens, Equality, Rights and Values Programme (2021-2027). EU officials or EU policymakers may participate; however, they are not the intended target group of this call, which is designed to engage citizens and civil society actors through participatory and interactive processes. Only the active and verifiable participation of citizens or stakeholders is considered eligible for the purposes of calculation of the lump sum.


Reporting and payment arrangements

The reporting and payment arrangements are fixed in the Grant Agreement (Data Sheet, point 4 and art 21 and 22).

After grant signature, you will receive no prefinancing.

Payment of the balance: At the end of the project, we will calculate your final grant amount. If the total of any earlier payments is higher than the final grant amount, we will ask you (your coordinator) to pay back the difference (recovery).

All payments will be made to the coordinator.

 Please be aware that payments will be automatically lowered if one of your consortium members has outstanding debts towards the EU (granting authority or other EU bodies). Such debts will be offset by us — in line with the conditions set out in the Grant Agreement (*see art 22*).

Please also note that you are responsible for keeping records on all the work done.

Prefinancing guarantees

If a prefinancing guarantee is required, it will be fixed in the Grant Agreement (Data Sheet, point 4). The amount will be set during grant preparation, and it will normally be equal or lower than the prefinancing for your grant.

The guarantee should be in euro and issued by an approved bank/financial institution established in an EU Member State. If you are established in a non-EU country and would like to provide a guarantee from a bank/financial institution in your country, please contact us (this may be exceptionally accepted, if it offers equivalent security).

Amounts blocked in bank accounts will NOT be accepted as financial guarantees.

Prefinancing guarantees are normally requested from the coordinator, for the consortium. They must be provided during grant preparation, in time to make the prefinancing (scanned copy via Portal AND original by post).

If agreed with us, the bank guarantee may be replaced by a guarantee from a third party.

The guarantee will be released at the end of the grant, in accordance with the conditions laid down in the Grant Agreement (art 23).

Certificates

Depending on the type of action, size of grant amount and type of beneficiaries, you may be requested to submit different certificates. The types, schedules and thresholds for each certificate are fixed in the Grant Agreement (*Data Sheet, point 4 and art 24*).

Liability regime for recoveries

The liability regime for recoveries will be fixed in the Grant Agreement (*Data Sheet point 4.4 and art 22*).

For beneficiaries, it is one of the following:

- limited joint and several liability with individual ceilings — *each beneficiary up to their maximum grant amount*
 - unconditional joint and several liability — *each beneficiary up to the maximum grant amount for the action*
- or
- individual financial responsibility — *each beneficiary only for their own debts*.

In addition, the granting authority may require joint and several liability of affiliated entities (with their beneficiary).

11. How to submit an application

All proposals must be submitted directly online via the Funding & Tenders Portal Electronic Submission System. Paper applications are NOT accepted.

Submission is a 2-step process:

- a) create a user account and register your organisation

To use the Submission System (the only way to apply), all participants need to [create an EU Login user account](#).

Once you have an EU Login account, you can [register your organisation](#) in the Participant Register. When your registration is finalised, you will receive a 9-digit participant identification code (PIC).

b) submit the proposal

Access the Electronic Submission System via the Topic page in the [Search Funding & Tenders](#) section (or, for calls sent by invitation to submit a proposal, through the link provided in the invitation letter).

Submit your proposal in 4 parts, as follows:

- Part A includes administrative information about the applicant organisations (future coordinator, beneficiaries, affiliated entities and associated partners¹⁹) and the summarised budget for the proposal. Fill it in directly online
- Part B (description of the action) covers the technical content of the proposal. Download the mandatory word template from the Submission System, fill it in and upload it as a PDF file
- Part C (KPI tool) containing additional project data. To be filled in directly online all sections to be completed.
- Annexes (*see section 5*). Upload them as PDF file (single or multiple depending on the slots). Excel upload is sometimes possible, depending on the file type.

The proposal must keep to the page limits (*see section 5*); excess pages will be disregarded.

Documents must be uploaded to the right category in the Submission System otherwise the proposal might be considered incomplete and thus inadmissible.

The proposal must be submitted before the call deadline (*see section 4*). After this deadline, the system is closed, and proposals can no longer be submitted.

Once the proposal is submitted, you will receive a confirmation e-mail (with date and time of your application). If you do not receive this confirmation e-mail, it means your proposal has NOT been submitted. If you believe this is due to a fault in the Submission System, you should immediately file a complaint via the [IT Helpdesk webform](#), explaining the circumstances and attaching a copy of the proposal (and, if possible, screenshots to show what happened).

Details on processes and procedures are described in the [Online Manual](#). The Online Manual also contains the links to FAQs and detailed instructions regarding the Portal Electronic Exchange System.

Use of artificial intelligence (AI) in proposals

When considering the use of generative artificial intelligence (AI) tools for the preparation of the proposal, it is imperative to exercise caution and careful consideration. The AI-generated content should be thoroughly reviewed and validated by the applicants to ensure its appropriateness and accuracy, as well as its compliance with intellectual property regulations. Applicants are fully responsible for the content of the proposal (even those parts produced by the AI tool) and must be transparent in disclosing which AI tools were used and how they were utilised.

Specifically, applicants are required to:

- Verify the accuracy, validity, and appropriateness of the content and any citations generated by the AI tool and correct any errors or inconsistencies.
- Provide a list of sources used to generate content and citations, including those generated by the AI tool. Double-check citations to ensure they are accurate and properly referenced.
- Be conscious of the potential for plagiarism where the AI tool may have reproduced substantial text from other sources. Check the original sources to **be sure you are not plagiarizing someone else's work.**
- Acknowledge the limitations of the AI tool in the proposal preparation, including the potential for bias, errors, and gaps in knowledge.

13. Important



IMPORTANT

- **Don't wait** until the end — Complete your application sufficiently in advance of the deadline to avoid any last minute technical problems. Problems due to last minute submissions (*e.g. congestion, etc*) will be entirely at your risk. Call deadlines can NOT be extended.
- Consult the Portal Call and Topic page regularly. We will use them to publish updates and additional information on the call (call and topic updates).
- Funding & Tenders Portal Electronic Exchange System — By submitting the application, all participants accept to use the electronic exchange system in accordance with the [Portal Terms & Conditions](#).
- Registration — Before submitting the application, all beneficiaries, affiliated entities and associated partners must be registered in the [Participant Register](#). The participant identification code (PIC) (one per participant) is mandatory for the Application Form.
- Consortium roles When setting up your consortium, you should think of organisations that help you reach objectives and solve problems.

The roles should be attributed according to the level of participation in the project. Main participants should participate as beneficiaries or affiliated entities; other entities can participate as associated partners, subcontractors, third parties giving in-kind contributions. Associated partners and third parties giving in-kind contributions should bear their own costs (they will not become formal recipients of EU funding).

Coordinator — In multi-beneficiary grants, the beneficiaries participate as consortium (group of beneficiaries). They will have to choose a coordinator, who will take care of the project management and coordination and will represent the consortium towards the granting authority. In mono-beneficiary grants, the single beneficiary will automatically be coordinator.

- Affiliated entities — Applicants may participate with affiliated entities (i.e. entities linked to a beneficiary which participate in the action with similar rights and obligations as the beneficiaries, but do not sign the grant and therefore do not become beneficiaries themselves). They will get a part of the grant money and must therefore comply with all the call conditions and be validated (just like beneficiaries); but they do not count towards the minimum eligibility criteria for consortium composition (if any). If affiliated entities participate in your project, please do not forget to provide documents demonstrating their affiliation link to your organisation as part of your application.
- Associated partners — Applicants may participate with associated partners (i.e. partner organisations which participate in the action but without the right to get grant money). They participate without funding and therefore do not need to be validated.
- Consortium agreement — For practical and legal reasons it is recommended to set up internal arrangements that allow you to deal with exceptional or unforeseen circumstances (in all cases, even if not mandatory under the Grant Agreement). The consortium agreement also gives you the possibility to redistribute the grant money according to your own consortium-internal principles and parameters (for instance, one beneficiary can reattribute its grant money to another beneficiary). The consortium agreement thus allows you to customise the EU grant to the needs inside your consortium and can also help to protect you in case of disputes.

- **Balanced project budget** — Grant applications must ensure a balanced project budget and sufficient other resources to implement the project successfully (*e.g. own contributions, income generated by the action, financial contributions from third parties, etc*). You may be requested to lower your estimated costs, if they are ineligible (including excessive).
- **Completed/ongoing projects**— Proposals for projects that have already been completed will be rejected; proposals for projects that have already started will be assessed on a case-by-case basis (in this case, no costs can be reimbursed for activities that took place before the project starting date/proposal submission).
- **No-profit rule** — Grants may NOT give a profit (i.e. surplus of revenues + EU grant over costs). This will be checked by us at the end of the project.
- **No cumulation of funding/no double funding**— It is strictly prohibited to cumulate **funding from the EU budget (except under 'EU Synergies actions')**. Outside such Synergies actions, any given action may receive only ONE grant from the EU budget and cost items may under NO circumstances be declared under two EU grants. If you would like to nonetheless benefit from different EU funding opportunities, projects must be designed as different actions, clearly delineated and separated for each grant (without overlaps).
- **Combination with EU operating grants**— Combination with EU operating grants is possible, if the project remains outside the operating grant work programme and you make sure that cost items are clearly separated in your accounting and NOT declared twice (see [AGA — Annotated Model Grant Agreement, art 6.2.E](#)).
- **Multiple proposals** Applicants may submit more than one proposal for *different* projects under the same call (and be awarded a funding for them).

Organisations may participate in several proposals.

BUT: if there are several proposals for *very similar* projects, only one application will be accepted and evaluated; the applicants will be asked to withdraw one of them (or it will be rejected).

- **Resubmission** — Proposals may be changed and re-submitted until the deadline for submission.
- **Rejection** — By submitting the application, all applicants accept the call conditions set out in this this Call Document (and the documents it refers to). Proposals that do not comply with all the call conditions will be rejected. This applies also to applicants: All applicants **need to fulfil the criteria; if any one of them doesn't, they must be replaced** or the entire proposal will be rejected.
- **Cancellation** — There may be circumstances which may require the cancellation of the call. In this case, you will be informed via a call or topic update. Please note that cancellations are without entitlement to compensation.
- **Language** — You can submit your proposal in any official EU language (project abstract/summary should however always be in English). For reasons of efficiency, we strongly advise you to use English for the entire application. If you need the call documentation in another official EU language, please submit a request within 10 days after call publication (for the contact information, see *section 12*).

- **Transparency** — In accordance with Article 38 of the [EU Financial Regulation](#), information about EU grants awarded is published each year on the [Europa website](#).

This includes:

- beneficiary names
- beneficiary addresses
- the purpose for which the grant was awarded
- the maximum amount awarded

The publication can exceptionally be waived (on reasoned and duly substantiated request), if there is a risk that the disclosure could jeopardise your rights and freedoms under the EU Charter of Fundamental Rights or harm your commercial interests.

- **Data protection** — The submission of a proposal under this call involves the collection, use and processing of personal data. This data will be processed in accordance with the applicable legal framework. It will be processed solely for the purpose of evaluating your proposal, subsequent management of your grant and, if needed, programme monitoring, evaluation and communication.
